## TERMS AND CONDITIONS

**CAMP FEES:** A registration cannot be confirmed unless: 1. Accompanied by a **Payment** for at least one week in full and, 2. A **\$10 non-refundable fee for each week reserved.**

**LATE FEES** A. There is a **late fee of \$5.00 for parents who pick-up their child after 4:30pm.**

B. There is a **late fee of \$1.00 per minute for parents who pick-up their child after 5:45pm. Both are payable on the same day with cash or e-transfer.**  
We reserve the right to dismiss your child from future camp attendance for unpaid balances.

**1. REFUNDS:** Should your plans change after registration, but before Feb 15<sup>th</sup> for March Break Camp and May 15<sup>th</sup> for the Summer Camp, your deposit will be refunded/returned, less a \$25.00 administration fee. PLEASE ALLOW 4 WEEKS FOR REFUND TO BE PROCESSED.

**2. CANCELLATION/CHANGES:** There are NO REFUNDS for SICK DAYS or MISSED DAYS. With the exception of extenuating circumstances, there will be no refunds for cancelled weeks. In the event of a cancellation, there will be a \$25 administration charge per week.

### 3. OTHER CONDITIONS:

A) The undersigned herein agrees that the duration and dates referred to herein are binding and non-transferable and that the duration is not divisible, therefore no credits or refunds shall be given for missed days due to sickness, absence or for any reason whatsoever (with the exception of extenuating circumstances). All final decisions are subject to the approval of the Valiquette Academy Foundation (VAF).

B) Overdue accounts are charged interest at 2% per month, and outstanding accounts will be sent to Small Claims Court for collection.

C) Children with any disability, sickness, medical affliction, allergy, whether chronic or not, are considered at risk while under the care of The Valiquette Academy Foundation and under all circumstances, the undersigned expressly agrees that the child enrolled and using all facilities, is at risk and hereby releases the Valiquette Academy Foundation and the Valiquette Academy, Camp Valiquette, its owner, agents, employees and management (henceforth referred to as: The VAF, its subsidiaries and agents) from any and all damages, loss or injury from or during the use of the Camp's facilities and/or participation in the Camp's programmes and outings.

D) The undersigned hereby absolves the Valiquette Academy Foundation (as well as its subsidiaries and agents) of all claims for loss of property during the camper's participation in the Camp programme.

E) The participant (in the case of a minor, the parent) expressly agrees that the VAF may take photos, videos, and sound recordings of its events, including all participants, and may use said material to publicize and promote the VAF and/or its subsidiaries, including but not limited to print, radio, television, and Internet.

F) The Camp has the absolute right to terminate the present contract for any justifiable reason to maintain the integrity and atmosphere of the services provided to others therein enrolled.

G) If any part of this Agreement shall be held void or not enforceable, the remaining part shall be in full force and effect.

H) It is hereby agreed that as of the present date, the Valiquette Academy Foundation has commenced performance of its obligations.

**J) There will be a \$20 charge for all incorrect spelling resulting in extra work to produce tax receipts (RL-24).**
